Retail Update

Over the past number of months, it has been an extraordinary performance by all of you in the retail trade. Despite all of the challenges we have all faced over the past number of months, the National Lottery with your help, is on course to raise in excess of €250 million in Good Causes funding for the second year in a row. The Good Causes fund represents a lifeline for community groups and projects, many of whom are facing real uncertainty in their on-going fundraising efforts.

On behalf of all of those worthwhile Good Causes who are set to benefit, we thank you for continuing to make a real difference in practically every community throughout the country.

2020 has been a life-changing year for many but none more so than our lucky winners. At the time of print, we have seen 23 brand new National Lottery millionaires made through our games. Following the lifting of a nationwide lock-down, we have enjoyed visiting and enjoying the (socially distanced) celebrations with our winning retailers in counties such as Cork, Donegal, Galway and Laois. A full review of the latest lucky retailers are featured inside this brochure.

As you may be aware, the much-anticipated return of the Winning Streak TV gameshow has not been possible due to public health restrictions which remain in place. We are disappointed to postpone the show but, given the unprecedented challenges posed by Covid-19, producing the programme while managing social distancing in studio, we feel, provides too much risk to players, their families and the staff who work on the show. As a result, Winning Streak scratch cards will not be made available for the foreseeable future.

In the absence of Winning Streak however, we are making huge efforts to roll out a number of exciting campaigns and special promotions which will be heavily supported by individual marketing campaigns and will drive further foot-fall in-store. September alone will see a special guaranteed €130 million EuroMillions draw and in addition, we will be supporting a heavily weighted nationwide advertising campaign for our All Cash scratch card family. This activity will run in conjunction with our always-on brand and jackpot advertising campaigns which are already in place.

Given the continued popularity of our games, we want to remind you of the importance of remaining vigilant to ensure that the protection of our players is at the forefront of what we do. To help support you in the responsible promotion of National Lottery products, we will be introducing new measures such as purchase limits for scratch cards and additional supports for stock management best practices which will reinforce our Responsible Play policy. These new practices will be fully supported by our retail support network and will be included in mystery shopper campaigns which will further help us to protect those most vulnerable in our society.

As the evening's grow shorter and winter approaches, it is that time of year in which we start to prepare to launch our ever-popular Christmas scratch card range. Our exciting range of festive scratch cards will be available very soon and with a top prize of €100,000 up for grabs it will go a long way to spreading some much needed festive cheer to one of your lucky customers!

We are always striving to improve our support services to our valued retail partners and I am delighted to reveal that we have further enhanced the resources available to our dedicated Retail Help Desk team to ensure a top class customer service experience. Purchase Limits – Scratch Cards

Maximum of 10 Scratch Cards per Transaction

Purchase Limits for Scratch Cards to be Introduced from 21 Sept 2020

In line with the National Lottery's commitment to the promotion of positive play in retail, PLI has decided to introduce limits to the number of Scratch Cards that can be purchased in any one transaction.

A new limit of 10 tickets per transaction will be introduced from 21st September and will serve as an additional control to help address two key areas of concern that could contribute to problem play: *limiting the total spend in any one transaction & enabling a break in the 'session of play'*.

The new limits will be mandatory across all retail points of purchase and the retailers' obligations in this regard to be incorporated into the Retail Sales Agent Compliance Policy. This change has already been reflected in an amendment to the Retail Agent Authorisation issued earlier this year..



In-Store Merchandising

Our Merchandising partners Lites have been in trade since mid-August visiting all licensed Lottery Retail Agents replacing existing compliance & age control material with a newly designed suite that calls out the new transaction limit on Scratch Card purchases. This campaign will be completed before the end of September when the new limits will come into force.

Retail Agent Obligations

From the 21st September 2020 retailers will not be able to sell more than 10 Scratch Cards in any one transaction. If a customer seeks to purchase more than 10 Scratch Cards, the Retailer is obliged to advise the player of the 10 ticket limit and not proceed with the sale.

This new regulation has been introduced in the interest of players with the purchase limit applicable to *a single or any series of contemporaneous transactions in a store by a single customer*.

Monitoring & Compliance

The new Purchase Limit restrictions will be added to the Retail Sales Agent Compliance Policy. Failure to comply with the new Purchase Limits will be considered a breach of the Policy and as such attract penalty points and sanction up to and including suspension/termination of the Retailers authorisation.

Non-compliance with Scratch Card purchase limits will be a Category 2 breach under the policy, a copy of which can be viewed in the Retailer Portal.

Retailers are advised that compliance with Scratch Card Purchase Limits may be tested as part of the National Lottery ongoing Mystery Shopper programme.

It is imperative that the new limit on Scratch Card purchases is brought to the attention of all staff dealing with the sales & promotion of Lottery products.

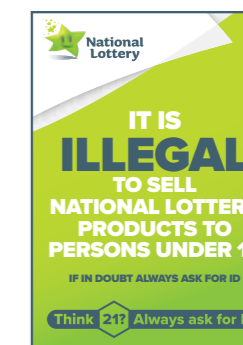

Responsible Play Awareness Campaign

Responsible Play Awareness Week – October 2020

The National Lottery is committed to providing Lottery games that are both exciting and engaging in a socially responsible way. We pride ourselves in doing everything we can to prevent problem play and sales to minors.

In line with that commitment the National Lottery is planning a dedicated Awareness Week to promote positive play and drive awareness of the various initiatives in place to protect the interest of players and retailers alike. The initiative will be supported by a National Media campaign, with specific activations across retail and on-line channels.

Full details will follow closer to the proposed launch date of 26th October 2020.

Winning Streak Postponed

Postponement due to on-going pandemic

The National Lottery and RTÉ have announced that Winning Streak will not be returning this Autumn due to ongoing restrictions related to Covid-19. Both National Lottery and RTÉ are disappointed to postpone the show but, given the unprecedented challenges posed by Covid-19, producing the programme while managing social distancing in studio, we feel, provides too much risk to players, their families (who travel from all over the country to support the player) and the staff who work on the show.

Winning Streak scratch cards, which were due to go on sale in August, will not go on sale until further notice. On the last Winning Streak show, March 7th, five players were drawn to appear on the next episode, which would have aired on March 21st. Before this could happen, the government restrictions in movement due to Covid-19 were introduced and unfortunately this resulted in the postponement of the March 21st show. The players were contacted and advised of the situation together with our intention to reschedule for a later date.

Additionally, in March we announced that any player who still had a three-star entry should continue to send those into the National Lottery until the 10th August in line with game rules and they would be included in a catch all draw at a later date.

Two game shows will now take place, one for those drawn in the catch-all draw and one for those drawn for the postponed show of March 21st. Each player will get the opportunity to play the full suite of Winning Streak games with the same prizes on offer, whilst at all times ensuring all social distancing and health and safety guidelines are followed. This event will not be broadcast on RTÉ television. Attendance will be in strict adherence to Government guidelines and will include players, the requisite National Lottery and KPMG personnel. The date for the event will be decided in the coming weeks in line with the most up-to-date guidance on public health measures. We will contact players directly in the coming weeks with the details of the event.

Stock Management

Activating Ticket Stock Prior To Sale

- **Always** activate a book of Scratch Cards before placing on sale.
- **Never** place a book of tickets on sale where the end activation date or game end data have passed.
- **Never** place book of tickets on sale where the attempt to activate the book has failed and/or a terminal message is displayed instructing not to do so
- **Always** contact the Retail Help Desk on 1800 22 44 55 when prompted by the message displayed on screen.

IMPORTANT Non-activation of Scratch Card stock prior to sale impacts a players ability to claim a prize and is the single biggest contributor to Retail compliance breaches and subsequent sanctions. Points accumulated from sanctions imposed can lead to suspension or termination of your licence.

How to activate a book of Scratch Cards

- To activate a book select the 'Scratch Card Menu' tab on the terminal screen and then select the 'Activate Book' option. Scan the barcode from any ticket in the book by simply placing the book on the terminal tray with the exposed back of the ticket facing upwards.
- When the book number is displayed on screen select the 'Activate Book' icon.



Scratch Card Management

- Always confirm delivery of Scratch Card stock on receipt.
- Check that the books contained in the order match those detailed on the delivery docket.
- **Always activate a book of Scratch Cards before placing on sale.**
- Never place a book of tickets on sale where the end activation date or game end date have passed.
- Never place a book of tickets on sale where the attempt to activate the book has failed and/or a terminal message is displayed instructing not to do so.
- Always return full book Scratch Card stock once instructed by the National Lottery.
- Never place a game on sale after the end activation date.
- Never sell tickets from a game once end game has been announced.

Prize Payments

- Always validate a prize through your terminal before paying out on any prize.
- Always follow the instructions on screen carefully to ensure the prize validation has been completed properly.
- Only pay a prize when the terminal has issued a prize payment receipt.
- Always give customer prize payment receipts to players after validating winning tickets for payment.
- Always return non-winning tickets to players with the auto-generated 'not a winner' receipt.
- It is a requirement to give customer receipts to players after validating winning tickets for payment.
- PLI monitor compliance through its Mystery Shopper programme.

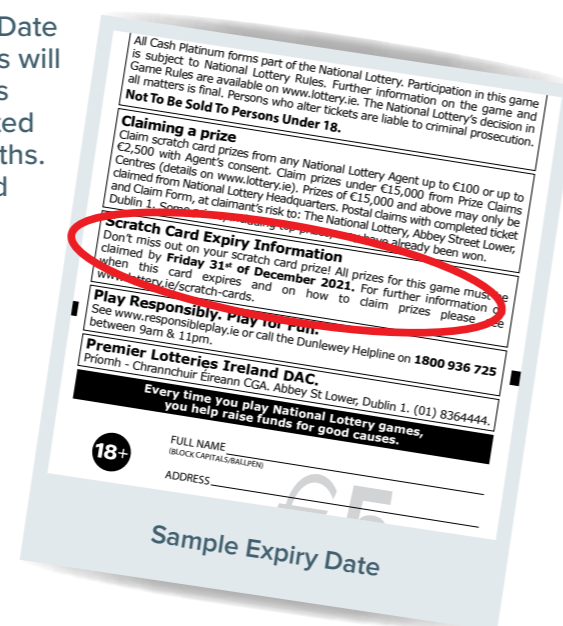
End Claim Date

As part of our ongoing commitment to ensuring the best possible experience for Players & Retailers the new generation of All Cash games have predetermined expiry dates printed on the back of each ticket.

This ensures

- The final date to claim a prize on any game is clearly communicated to the player, limiting any confusion as to the validity of a ticket.
- Retailers are aware of the expiry date of each game to support better stock management practices.
- Tickets are not offered for sale after the game end date which would impact the Players right to claim a prize.

The next new ticket Lucky 7's Game 240 also has an End Claim Date of 29th July 2022 printed on the back of the tickets. Expiry dates will be introduced on a phased approach as new Scratch Card series are released to market. PLI expect to have End Claim dates printed on all Scratch Cards games in the portfolio with the next 12 months. Remember these dates will continue to be clearly communicated to Retail as part of the Game End Process and published in Star Game News and the Retailer Portal.

Cancellations & Prize Payments

Cancellation - Rules

- All Draw Based Game tickets can be cancelled with the exception of TellyBingo & Millionaire Raffle.
- Tickets must be cancelled within two hours of generation or 'Draw Break', whichever occurs first.
- Please remember it is best practice to always cancel a ticket where a customer, for whatever reason has decided not to proceed with the sale.
- **Do not offer that ticket for sale to another customer**

How to Cancel a Draw Game Ticket

- Manually mark the ticket by drawing a series of lines between the closed brackets as shown – **DO NOT MARK OUTSIDE BRACKETED AREA**
- Select the 'CANCELLATION' icon in the Terminal Function tool bar
- Place ticket on terminal tray
- 35-digit barcode is read & the ticket details are displayed in preview screen
- Press the 'PERFORM CANCEL' to cancel the ticket
- A cancellation receipt is printed which should be retained with the ticket for reconciliation/balancing purposes
- This ticket is now 'VOID' and cannot be offered for sale to another customer



Prize Payments

Paying out on a Winning Draw Game Ticket

- To pay a prize on any Draw Based Game select the 'VALIDATION' icon in the 'Terminal Function' toolbar and place the ticket on the terminal tray.
- The validation screen appears displaying the ticket details and if the prize value is €100 or less, the ticket is validated automatically and two receipts printed, one to be retained for your records and the other to be given to the customer along with their prize winnings.
- Please remember that it is a requirement to give the customer the prize payment receipt after any prize has been validated for payment.
- If the ticket presented is not a winner, the ticket should always be returned to the player along with the 'NOT A WINNER' receipt which will print automatically.

IMPORTANT – Prize Payments over €100

- Tickets with a prize value of €101 and up to €2,500 will not validate automatically
- Once presented in the terminal tray and barcode read a message appears on screen with the prize value asking if you have sufficient cash in the till to pay the prize
- If you wish to proceed with the payment you must select 'YES' and then 'PAY' to validate the ticket.
- Two receipts are printed, one to be retained for your records and the other to be given to the customer along with their prize winnings.
- If you do not wish to pay the prize simply press 'NO' and give both the ticket and the 'Claims Receipt' which will print automatically back to the customer and advise them that prizes of this value can be paid at any Post Office

A Claims Receipt is simply a receipt showing the value of the prize with information on where that prize can be redeemed. NEVER pay out any prize on the basis of this receipt as the prize has not been validated.

Remember always follow the instruction on screen when validating any prize and only pay out a prize when the terminal has issued two prize payment receipts, one for the customer and the other for your records.

Winner Awareness

€7.3 million Lotto winner out West!

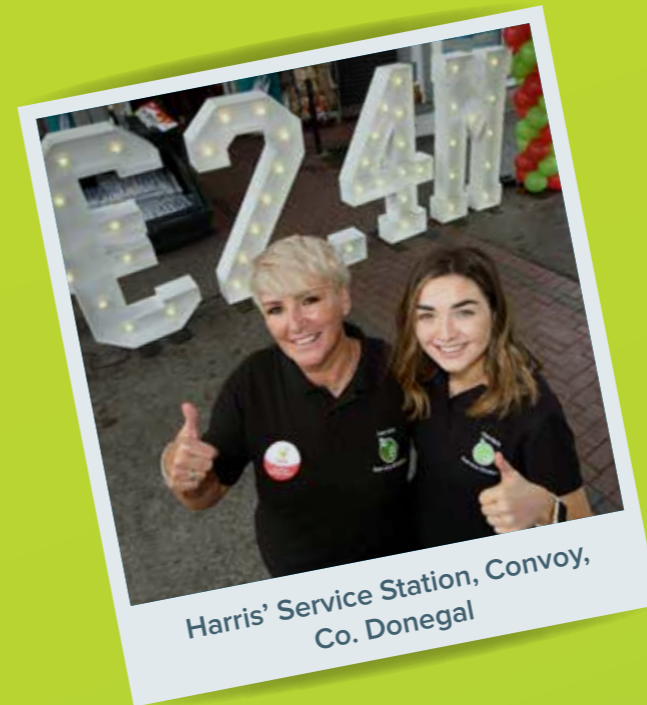

Good Causes Awards



National Lottery announces €95,000 prize fund for Ireland's most inspiring clubs and community organisations and projects with Good Causes Awards.

Nationwide awards celebrate inspiring work in communities all over Ireland powered by National Lottery Good Causes funding.

The National Lottery has announced details of the **National Lottery Good Causes Awards**, with a total prize fund of €95,000, which honours the inspiring work and achievements of thousands of projects, clubs and individuals all over Ireland, who, with the help of National Lottery Good Causes funding, have had an extraordinary impact on their local communities.

The awards ceremony will take place on Saturday 20th February 2021 in the Mansion House in Dublin City Centre.



The finale will be presented by broadcaster and journalist, Grainne Seoige and the competition's judging process will be chaired by Lotto presenter and RTÉ weather broadcaster, Nuala Carey. Both launched the National Lottery Good Causes Awards, which is now in its third year.

Speaking on launching the awards, Nuala Carey said it is fitting that the profound impact of various Good Causes in villages, towns and cities all over Ireland, is recognised.

She said: **"The National Lottery is used to celebrating winners. However we have thousands of winners, unsung heroes, who work quietly under the radar to make positive change in their communities and these Awards reflect that dedication and commitment. I was lucky enough to witness this having being on the judging panel for the national finals of the Good Causes Awards for the past two years so this year I am thrilled to be chairing the panel of judges."**

"Through the National Lottery Good Causes Awards we want to show how ordinary, everyday people, organisations, projects and sports clubs are doing extraordinary things in their communities. This is work that often goes unrecognised and we are encouraging Good Cause beneficiaries to enter these awards to give them the opportunity to have their hard work honoured", she added.

Grainne Seoige, who will host the awards for the second consecutive year, said: **"Presenting last year's awards was a truly humbling experience. The one thing that really shone through for every finalist was a strong sense of community, whether it was amongst their local towns, fellow colleagues in their community project and even users of the vital services each beneficiary provided. Community is something that is always strong throughout Ireland so I am delighted to be presenting these awards again."**

Jennifer Crowe, CSR and Good Causes Relationship Manager of the National Lottery said: **"Without question, 2020 has been a really challenging year for the thousands of voluntary community organisations, sports clubs, NGOs and charities who rely so heavily on fundraising. The Good Causes Awards have always aimed to shine a light on beneficiaries of National Lottery funding and this year is no different. In addition, National Lottery funding would not be possible if it were not for our players all over the country so I thank them for their continued support."**

Individuals, community projects and organisations who received Good Causes funding between the years 2014 to 2019 (inclusive) are eligible to apply.



Applications for the Awards are now open and people can enter and check eligibility at www.lottery.ie/goodcausesawards.

The Awards will have seven categories which will culminate to an awards luncheon on Saturday 20th February 2021 in the Round Room in the Mansion House in strict adherence to Government health guidelines with regard to COVID-19.

The seven categories are:

- Sport
- Health & Wellbeing
- Arts/Culture
- Heritage
- Community
- Youth Affairs
- Special Category: Irish Language

Each of the seven category winners receiving €10,000 and the overall Good Cause of the Year winning an additional €25,000.

EuroMillions Promotion

EuroMillions Super Minimum Jackpot Guaranteed*

On Friday the 25th September EuroMillions will run a GUARANTEED JACKPOT Promotion.

This draw will take place community wide. The mechanic is the same as every other Jackpot draw but irrespective of the Jackpot size on Friday September 25th, the Jackpot will be a guaranteed €130 million.

If the Jackpot is not won, the Jackpot in the following draw will continue in roll from the €130m base, to a predicted €145m and so on until it is won.

This will be the third EuroMillions SMJG promotional event in 2020.

On Saturday 24th October, a GUARANTEED €1 Million will be added to the Lotto Plus RAFFLE

This is the fourth Lotto Plus €1 Million Raffle in 2020 and tenth overall.

How to I play?

Buy a Lotto Ticket with Plus as normal, for each line on the ticket you get a non-unique raffle code between 0001 - 9999.

Remember to check your raffle codes after every draw!
